President's Message

Greetings,

OHHA is back. Back on solid ground. Back with a new vision. And back continuing to represent the interests of Ontario's Harness Horse People. It's an exciting time to be an OHHA member. And as your president I couldn't be prouder.

We are where we are now because of hard work, perseverance and a commitment to innovation and change. And none of this would have been possible without the support of Premier Doug Ford, Labour Minister Monte McNaughton, their staff and the many MPPs who backed us along the way. I sincerely thank Premier Ford for his unwavering support of the horse industry in Ontario and congratulate him and his team on their resounding June 2 victory.

I am so proud of the work OHHA has done founding and developing the Ontario Equine Education and Employment program (OEEEP); a joint initiative sponsored by OHHA and the Ministry of Labour, Training and Skills Development, delivered in partnership with VPI Employment, Equine Guelph and horse people from various breeds throughout the province. Without skilled, dedicated and gualified workers the industry can not be supported. OEEEP is a major step towards ensuring industry viability in both the short and long term.

But anyone who knows me knows I don't sugarcoat things. There are some hard truths and challenges facing the harness horse industry. Issues around funding, promotion and long term prosperity are at the forefront. This year alone we have had 21 race date cancellations that were non-covid related.

Simply put, if we are going to save our industry we have to develop a long term plan that doesn't rely solely on government subsidies. While we truly appreciate the support we receive, relying on the government of the day to sustain horse racing is no plan at all. Having all our eggs in the WEG basket is no plan at all. Having no connection between mutuel handle and purses is no plan at all. In fact, I'm always shocked by the lack of industry awareness that not one dollar of mutual handle goes

towards purses in Ontario. It's time to examine ways mutuel handle, in fact all forms of sports wagering and gaming can be allocated to support Ontario's equine agricultural industry.

Grass roots industry participants, not high priced race track executives should be the beneficiary of our labour and our efforts. Now is time to proudly make a stand for the things that matter to us; our families, rural Ontario, agriculture and the horses we all love and care for.

It won't be easy. Anything worthwhile never is. And it will take a concerted effort to be heard. We are up against some high powered people with fancy titles. I'm up for it, but I can't do it alone. Now's the time to come together. It's our time. Let's get it done.

Did You Know?

1

The Ontario Harness Horse Association (OHHA) was formed in 1962 and is the only legitimate voice of Harness Horse people.

2

Historically, OHHA negotiated contracts between Standardbred racetrack operators, including the former Ontario Jockey Club (now WEG) and horse people until 2009. While there was no horseman's contract in early 2009, In order to be federally approved for a wagering permit WEG utilized access waivers with horse people. These waivers contained race date scheduling and revenue sharing language as proof that an agreement existed with horsepeople.

In 2009 WEG facilitated the establishment of a management friendly association, Central Ontario Standardbred Association (COSA) and strongly suggested horse people become members of COSA in order to race at the WEG tracks. OHHA continued to negotiate contracts with other Ontario standardbred race tracks until 2019.

The initial contract between WEG and COSA prohibited COSA from representing industry members in any legal proceeding, thereby eliminating representation rights for horse people.

5

In 2009, WEG directed the OHHA share of purse funds to COSA.

6

OHHA received revenue share from purse allocation from non WEG tracks until 2019.



In January 2019, Ontario Racing (OR) issued a notice to redirect those funds to COSA, in effect cutting off all revenue sources for OHHA.



In January 2021, OHHA was on the brink of insolvency, having exhausted all existing funds.

Faced with dissolving, OHHA entered into talks with the provincial government to establish a work and learn skills development program through the Ministry of Labour, Training and Skills Development.



In July 2021, The Ontario Equine Education and Employment Program funded by the Ministry of Labour, Trade and Skills Development was launched by OHHA, supported by community partners, the University of Guelph and VPI employment.



OHHA is now working through its 6th cohort, successfully placing workers in various stables throughout the province.

Though liability insurance can no longer be offered to participants, OHHA continues to operate through its Campbellville, Ontario office.

Ontario Harness Horse Association Registered Retirement Savings Plan

OHHA continues to administer the industry RRSP on behalf of the owners, breeders, trainers, drivers, and grooms that participate in standardbred breeding and racing in Ontario.

Eligibility for Program Membership:

You may join the OHHA retirement program at any time if you are an Ontario standardbred industry participant. When you make your annual contribution, you may be eligible for an industry contribution to your account. Annual contributions must be received by the OHHA office by December 1, 2022, to be eligible for the industry contribution.

Criteria for the OHHA contribution to your account:

- horse ownership).
- trainer of record/employer who has met the eligibility criteria.
- record/employer who has met the eligibility criteria.
- registered Ontario Sires Stake eligible stallion standing in Ontario and nominated to the OSS program.
- the Income Tax Act (Canada).

Ontario Harness Horse Association Life, Health, and Dental Insurance Program

OHHA members may obtain Life, Health and Dental insurance through the group insurance plan provided by Canada Life. Breeders qualify as the owner or lessee of a broodmare with racing offspring who have accumulated 10 Ontario racing starts in the previous year or are the signing officer of a

If you cannot meet the qualifying standard of 10 starts in any given year, you should apply if you are close to meeting the criterion. Upon request of a member, OHHA will review each case on an individual basis to determine if the OHHA contribution will be made. However, even if you do not qualify for the OHHA contribution, you may still make your own contribution to the plan. At the end of the year in which you turn 71, you are excluded from the Plan in accordance with
